BIOGRAPHIE

Noradèle Radjai fait partie de l'équipe d'arbitrage international en tant qu'associée, elle est spécialisée en arbitrage commercial et arbitrage d'investissement dans les secteurs de l'énergie (notamment du pétrole et du gaz), des télécommunications et de la construction. Elle intervient aussi en tant que conseil pour des clients du Moyen-Orient ou concernant des projets ou contrats en Moyen-Orient.

Me Radjai a agi comme conseil, avocate et arbitre dans de plus de 50 procédures d'arbitrage internationales, aussi bien ad hoc qu'institutionnelles (soumises aux règles CCI, LCIA, SCC, CIRDI, AAA/ICDR, UNCITRAL et aux Swiss Rules), notamment dans des litiges découlant de cessions et acquisitions de parts sociales, de *joint ventures* ou de grands projets, soumis à diverses lois procédurales et de fond, dont les droits suisse, anglais, libanais, français, russe, chypriote, californien et de New York.

Me Radjai est hautement reconnue par les principaux annuaires juridiques. Elle était classée parmi les 5 meilleurs arbitres du monde de moins de 45 ans dans le *Who's Who Legal : Future Leaders – Arbitration 2017* et figure actuellement dans le classement mondial de *Who's Who Legal* pour tous les praticiens de l'arbitrage. Elle figure également dans le classement européen et suisse des meilleurs avocats conseil en arbitrage de Chambers Global et Chambers Europe.

Me Radjai est Vice-Présidente du Comité d'arbitrage de l'IBA (ainsi que co-présidente du *Corporate Counsel Subcommittee*), membre du comité exécutif du conseil d'administration de l'ASA (Association Suisse d'Arbitrage), membre du *Pledge Steering Committee* et du *CPR European Advisory Board*.
