Ban on all transactions with the Central Banks



Ban on all transactions with listed state-owned companies (SOEs)



Ban on the dealling with securities and moneymarket instruments



Ban on export of military goods (incl. dual use of goods and technology, brokering services and financing)



Ban on granting loans



Ban on flights over airspace and airport carrier access



Ban on accepting deposits exceeding EUR/CHF 100,000



Ban on exports (aviation and space-related, oil and luxury goods sectors)



Ban of certain banks from SWIFT's messaging system



Ban on the import of specific iron and steel products



Ban on providing credit rating services (CRAs)



Ban on new investments in the energy sector



Ban on public financing



Suspension of media outlet broadcastings

#### **Other Sanctions**

Ban on import of goods and tourism-related services on the non-government-controlled areas of Donetsk, Luhansk, Crimea and Sevastopol.
