The promotions underscore the firm's growth and its targeted development of its own talent in Geneva, Zurich, and London, according to a press release.

Laura Azaria and Robert Bradshaw have been appointed partners in the area of international arbitration, as have Adam El-Hakim, Christian Exner, and Sébastien Zulian in the area of litigation. The firm has also promoted Isabel San Martín (International Arbitration) and Nikita Ognivtsev (Litigation) to Counsel.

Extensive expertise in arbitration and litigation

Laura Azaria, who has been with the Geneva office since 2014, has extensive experience in international arbitration and complex commercial disputes, including cases involving infrastructure projects, M&A transactions, and technology-related disputes. Her recent mandates include the successful defense of major cases before the Federal Supreme Court, including Yukos Capital v. Russia.

Robert Bradshaw, one of the first team members of the London office, specializes in commercial and investment arbitration with a focus on energy and commodities. His work includes the successful enforcement of GreenX Metals' £252 million claim against Poland and the multibillion-pound case brought by Gate Gourmet against Asiana Airlines.
